2. Hours are from 6:00 a.m. to 10:00 p.m.
3. Fires are allowed only in barbecue pits and must be completely out before leaving the picnic area.
4. No firearms or explosives.
5. No Jump Houses.
6. No Water Slides.
7. Dogs must be on a leash.
8. No golf playing.
9. No vehicles or motorcycles beyond the parking lot.
10. Bicycles must be wheeled or pushed by hand over grassy or wooded areas.
11. No radios, amplified music, generators, or other sound producing equipment is allowed.
12. No piñatas allowed.
13. No skate board riding in park or on tennis courts.
14. Volleyball nets are always up. Volleyballs and horseshoes may be reserved at \$10 a day.
