- 4. No firearms or explosives.
- 5. No Jump Houses.
- 6. No Water Slides.
- 7. Dogs must be on a leash.
- 8. No golf playing.
- 9. No vehicles or motorcycles beyond the parking lot.
- 10. Bicycles must be wheeled or pushed by hand over grassy or wooded areas.
- 11. No radios, amplified music, generators, or other sound producing equipment is allowed.
- 12. No piñatas allowed.
- 13. No skate board riding in park or on tennis courts.
- 14. Bocce Ball courts may be reserved at \$20 per court.
